REPORT ON TEACHING STAFF APPOINTMENTS **FOR EFFECTIVE TEACHING-LEARNING PROCESS**

Introduction:

Antyoday Mahavidyalaya, Devgram, under the affiliation of Rashtrasant Tukadoji Maharaj Nagpur University (RTMNU), is committed to delivering high-quality education for undergraduate and postgraduate programs in the rural region of Narkhed, Dist. Nagpur. The university has sanctioned 49 teaching posts for the academic session 2023-2024 to support the institution's mission of academic excellence. Of these, 46 posts have been filled, ensuring that the majority of programs are adequately staffed. This staffing level allows the college to implement an effective teaching-learning process that meets both university standards and the expectations of the local community.

Staffing Status and Distribution:

Out of the sanctioned 49 teaching positions, 46 have been successfully filled with qualified educators across various UG and PG departments, including **Botany, Chemistry, Computer Science, Physics, Zoology, Library Science, and Commerce** at the undergraduate level, and **Commerce, Economics, English, Marathi, Political Science, Computer Science, Mathematics, Microbiology, and Chemistry** at the postgraduate level. This distribution aligns with the institution's commitment to providing comprehensive instruction and specialized expertise in both the sciences and humanities, ensuring that students at each level have access to knowledgeable faculty.

Impact on Teaching-Learning Process:

The near-complete staffing has a positive impact on the overall teaching-learning process. With a majority of the posts filled, the college is able to offer consistent classroom engagement, ensuring that each subject is covered thoroughly and in alignment with the university's curriculum. Faculty members bring diverse expertise and employ various teaching methods, including **lectures, practical sessions, seminars, and workshops**, which enriches the learning experience. These methods foster active participation, critical thinking, and practical skill development among students, which are essential for academic success and professional readiness.

The availability of faculty in key areas also facilitates **personalized student guidance** and mentorship, allowing students to receive one-on-one support as they navigate academic challenges, research projects, and career planning. This structured and accessible teaching environment contributes to high student satisfaction and better learning outcomes, as students feel supported in their academic journeys.

Addressing Staffing Challenges:

While 46 of the 49 sanctioned posts have been filled, three positions remain vacant, which the administration is actively working to address. Efforts to recruit additional qualified educators are ongoing, with the administration exploring both permanent and temporary (ad hoc) options to ensure continuity in the teaching-learning process. In the interim, the college has managed any staffing gaps by engaging guest lecturers and utilizing existing faculty to cover critical topics, ensuring minimal disruption to students' learning experience.


Commitment to Quality Education:
