- 132. You are required to strictly abide to the Service Conduct Rules in which you are liable to maintain at all times Absolute Integrity, Devotion to duty and shall not contribute unbecomingness either to the institution(s) and or to any staff members.
- 133. In case of misconduct, misbehavior or disobedience on your part, your services are liable to be terminated within 24 hours prior notice.
