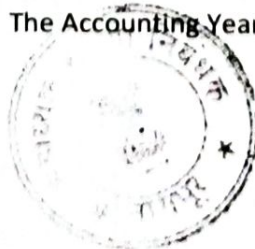

3 **MEMBERSHIP AND ITS PROCEDURE: -**

Any Indian person who has completed his/her 18 years of age can become the member of society for that he/she will have to apply for the membership to society.

The membership will be confirmed subject to the approval of executive committee by majority. The membership fee can be deposited in advance after which his/her name can be enrolled in members list.

4 **KIND OF MEMBERSHIP: -**

There will be only two types of Membership.

1) **LIFE MEMBER: -**

Any person shall be eligible to become a life member by compounding his membership subscription of Rs. 3000/- Single payment.

2) **ORDINARY MEMBER:-**

Any person shall be eligible to become member of the Sanstha by paying annual subscription of Rs. 500/-

5 **CESSATION OF MEMBERSHIP: -**

The membership may be terminated on resignation, misbehavior or misconduct. Any member who violates the Rules and Regulation of the Society or acts prejudicial to the interest of the Society, shall be liable to be expelled from the. Membership of the Society by a Resolution passed by the Executive committee. If any Member remains absent in consecutive three meetings then membership shall be automatically terminated. Rule of termination shall be applicable to both life members and Ordinary members. Before cessation of that member, society has to send him 15 days prior notice to listen his clarification

6 **ANNUAL GENERAL BODY MEETING IT'S POWERS AND DUTIES –**

The Annual General Body Meeting of the Society shall be held every year. The following business will be transacted at the Annual General Meeting.

1. To consider and pass the yearly accounts.
2. To adopt the budget estimates of the ensuing year.
3. To amend the Rules and Regulation, If necessary.
4. To hold election of the Executive Committee after five year.
5. Any other business with the permission of the chairman.
6. To organize and maintain activities, courses, classes and facilities to attain the objectives of the society.

7. NOTICE AND QUORUM OF THE GENERAL BODY MEETING –

All the meetings will be called by the Gen. Secretary or President. General body meeting will be held once in a Twelve Months. Notice for the annual General Meeting will be sent before 15 days. The quorum for the Annual General Body Meeting will be 2/3 rd of the Societies total members. The Quorum will not be necessary for the adjourned meeting.

The annual meeting of the General body will be held in the month of April. If Quoram of meeting is not completed, meeting will be adjourned for 30 minutes. The Notice of meeting will be served by hand delivery, E-mail then only send him notice by R.P.A.D. Post.

8. SPECIAL GENERAL BODY MEETING IT'S POWERS AND DUTIES –

The Special General Body Meeting will be held as and when felt necessary by the Executive Committee. The Powers and duties will be as per the General Body Meeting. The Notice of meeting is Served by Registered A.D. Post or by Hand Delivery. The quorum for the Annual General Body Meeting will be 2/3rd of the Societies total members. The Quorum will not be necessary for the adjourned meeting.

9. EXECUTIVE COMMITTEE AND IT'S OFFICE BEARERS –

The Executive Committee shall be of 07 members. The office Bearers will be as follows.

All the meetings will be called by the Gen. Secretary or President. The Notice for Executive Committee will be sent before 7 days. The Quorum for the meeting will be 1/3rd of the total members of the Executive Committee. If the Quorum is not completed, meeting will be adjourned for 30 minutes. The Notice of meeting will be served by hand delivery, or R.P.A.D Post. Meeting can commence After 30 minutes.

14. RULES FOR ELECTION OF THE EXECUTIVE COMMITTEE –

The Members who are not in arrears of any dues of the Society till the filling of his nomination papers will be eligible to contest. Election officer will be appointed before 30 days and Notice of election will be given 15 days before the election date.

15. FILLING OF VACANCIES OF THE EXECUTIVE COMMITTEE –

If any member resigns or dies, the remaining Executive Committee shall fill up the vacancies by passing the necessary Resolution by 2/3rd majority. Any member wishing to resign from the Society, shall send his resignation in writing to the President or Secretary.

16. POWERS AND DUTIES OF EXECUTIVE COMMITTEE –

The Executive committee is the sole and Supreme Authority for all organizational matters, management and decisions etc. Executive committees will have power to appoint and dissolve Sub-Committee for the proper management of the society as and when necessary. Executive committee may check accounts of any sub committee and it shall control all expenditure of the Sanstha.

The committee can expell any member and appoint any member.

17. FUND AND INCOME –

Membership fees. Other fees and Subscriptions. Donation and Government Grants, Bank Interest, Mutual fund, sale and Purchase of Shares will be the income of the Society.

21. BANK ACCOUNT-

The Bank Account will be in the name of the Society. The account will be operated by the Joint Signature of any two out of President, Secretary. And Treasurer of the Society. However bank account shall not be handelled by two members from same family.

22. MEMBERSHIP REGISTER. –

According to section 15 of Societies Registration Act, 1860, the list of members shall be kept in accordance with schedule vi, Rule 15 of the Sicieties Registration. Maharashtra Rules, 1971.

23. AMENDMENT TO THE RULES AND REGULATIONS. –

Any amendment to the Rules and Regulation shall be passed by 3/5 Majority in the Annual General Body meeting as per the provisions of section 12 of the Societies Registration Act, 1860.

24. CHANGE IN THE NAME AND OBJECT OF THE SOCIETY. –

The Name and Object of the Society or its amalagamation shall be done in accordance with the Section 12 or 12 A of the societies Registration Act, 1860.

25. DISSOLUTION. –

The Society shall be dissolved by the 3/5 of the majority in the General body Meeting as per the provisions of the section 13 and 14 of the Societies Registration Act. 1860. All property of the Society can be transferred to the associatin having same object before the dissolution of society. The accounts of Debts and credits of society will be completed.
